## ANNUAL BUSINESS CONFERENCE/MEETING

S.L.A.A. began December 30, 1976 with four people who found each other through Alcoholics Anonymous and believed they were suffering from sex and/or love addiction. These people agreed to meet on a regular basis to foster support and as a means to stop the obsessive and compulsive behavior that was causing them pain...

As the program began to flourish, there came a need to address issues that were affecting the Fellowhsip as a whole in a formal and constructive way. In 1980, S.L.A.A. adopted a Motion to incorporate...so on January 14, 1984, the first meeting, known then as the F.W.S. Conference was held and has been held annually since then, with the exception of 1986.



### Service and Responsibility in S.L.A.A.



Where do we get our **MONEY**? Fellowship-Wide Services 22% contributions (individuals, groups, intergroups) 75% sales of literature

Our fiscal year runs Sept 30-October 1 annually.

Our prudent reserve goal is \$206000 which is 75% of our annual operating expenses (9 months of expenses). We have this money in an interest bearing account and are now sitting at \$201,000. If the budget is approved by the Board of Trustees, the prudent reserve would increase to \$212,000. Prudent reserve funds protect us in the event of a catastrophe (such as a hurricane.)
